A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SEBASTOPOL
APPROVING ASSIGNMENT OF THE COLLECTION SERVICES AGREEMENT
FOR SOLID WASTE, RECYCLABLE, AND COMPOSTABLE MATERIALS
COLLECTION AND STREET SWEEPING BETWEEN REDWOOD EMPIRE
DISPOSAL, INC. AND RECOLOGY, INC.

WHEREAS, the Sebastopol City Council desires to maintain effective solid waste collection and disposal services for City residents; and,

WHEREAS, the Sebastopol City Council fully supports the reduction of solid waste disposal in landfills through recycling and reuse of materials; and,

WHEREAS, effective January 1, 2009 the City of Sebastopol entered into a Collection Services Agreement for Solid Waste, Recyclable, and Compostable Materials Collection and Street Sweeping Services with Redwood Empire Disposal, Inc. which carries an end date of December 31, 2023; and,

WHEREAS, via letter dated August 18, 2017, Redwood Empire Disposal, Inc announced its sale to Recology, Inc.; and, the Sebastopol City Council

WHEREAS, via letter dated August 18, 2017, Redwood Empire Disposal, Inc and Recology, Inc. requested per the provisions of the Collection Services Agreement the Sebastopol City Council approve assignment of the Collection Services Agreement from Redwood Empire Disposal, Inc. to Recology, Inc.; and,

WHEREAS, City of Sebastopol staff have examined Recology financial data and solid waste industry regulated compliance records (via CalRecycle data); and,

WHEREAS, City of Sebastopol staff have received Recology correspondence containing descriptions of the Recology plan to maintain and continue operations for the City as per the assigned Collection Services Agreement; and,

WHEREAS, City staff have performed due diligence and determined Recology has the resources to be able to effectively carry out the obligations listed in the Collection Services Agreement;

NOW, THEREFORE BE IT RESOLVED, that the City Council hereby consents to the assignment of the Collection Services Agreement from Redwood empire Disposal, Inc. and Recology, Inc.
