INTRODUCTION: This item is to request City Council review for approval three Temporary Use Permit Applications for the retail sale of regulated fireworks by Service Clubs of Sebastopol.

BACKGROUND: City of Sebastopol Resolution #3082 authorizes issuance of Temporary Use Permits for the retail sale of fireworks in the corporate City limits. The period of sale is from 12:00 noon, June 28th through 12:00 midnight July 4th.

DISCUSSION: The following three applicants have applied for the Temporary Use Permits and have sold fireworks last year:

Sebastopol Gravenstein Lions Club
 Sebastopol Sea Serpents
 V.F.W. Post #3919

The fireworks stand vendors are required to provide proof of insurance, a valid California State Fire Marshall License and must meet strict fire regulations on the sale and storage of the fireworks. The Temporary Use Permit is not valid until these requirements are met.

RECOMMENDATION: That the City Council approve these Temporary Use Permit applications for this year for the retail sale of fireworks in the corporate City limits, and review for next year the Fire Chief's recommendation to ban all sales and use of fireworks in the City of Sebastopol based upon an analysis on California's Fire Behavior and Fire Conditions.
