INTRODUCTION/PURPOSE:

This item is to obtain City Council approval to Award of Contract (Contract Number: 2020-01) Park Village Apartment Renovations for a contract amount of \$202,369 and adopt a minute order authorizing City Manager to execute all documents required to enter into contract with August-Jaye for the project.

BACKGROUND:

Beginning in 2017, the City has spent considerable resources making infrastructure improvements to Park Village, a mobile home park owned by the City. Through these efforts Park Village is well into a transition from a dozen mobile homes targeting providing affordable housing, to include providing temporary, transitional housing for homeless individuals, families, and others in need. Vital to this increased role has been the City partnership with West County Community Services, and invaluable input and assistance from a citizen volunteers known as the "Group of Advocates." Several sources of grant money have been made available, including several pending grant awards for Park Village managed by the Community Development Commission (CDC).

DISCUSSION:

Park Village includes a modest-sized building, raised to get above flood level, which had been used for four non-standard sized apartments but had been vacant and in difficult shape for several years.

Current plans call for the apartments to get rehabilitated and turned into two code-acceptable apartments. Initially CDC wished for the apartments to be ADA accessible and had approval plans for a third grant for an additional \$45,000 to pay for meeting ADA and design by an ADA architect. However CDC backed away from that requirement (including the ADA-specific grant money). As a result, to save expense, City staff have developed a set of plans and a bid package in-house. The plans and specifications were presented for Council concurrence to issue the project for bid. The project budget is \$335,000 (sum of the two grant awards) for renovating two apartments with utilities service for water, sewer, and electricity. \$23,500 of the \$335,000 is budgeted for electrical service upgrades to be performed by specialists separate from the work in the bid, resulting in the contract budget of \$311,500.

This is the anticipated scope of work:

- 1. Demolish interior improvements and select interior walls.
- 2. Construct new walls and doors.
- 3. Replace existing windows with dual-glazed units to match.
- 4. Install new electrical, above-floor plumbing, new water heaters and space heaters.
- 5. Install new insulation in ceiling, exterior walls, party wall and below floor.
- 6. Install new drywall on walls and ceilings.
- 7. Install new kitchen appliances and cabinets.
- 8. Install new bathroom tub/showers, toilets and sinks.
- 9. Finish and paint all interior walls.
- 10. Install new floor coverings.
- 11. The existing 4-unit electrical panel will be replaced with a new, 2-unit panel by others (DC Elec under separate contract).
- 12. Repair or replace roof and gutters.
- 13. Paint exterior

A bid process occurred which resulted in receipt of seven bids; the bid tabulation is attached. August-Jaye Construction had the low bid of \$202,369; their bid was considered complete and acceptable. The bid results:

August-Jaye furnished four references, all were contacted with very positive results.

Staff requests that Council authorize the City to contract with August-Jaye for the renovation of the two Park Village Apartments for a contract amount of \$202,369.

PUBLIC COMMENT:

As of the writing of this staff report, the City has not received any public comment. However, staff anticipates receiving public comment from interested parties following the publication and distribution of this staff report. Such comments will be provided to the City Council as supplemental materials before or at the meeting. In addition, public comments may be offered during the public hearing.

This item was noticed in accordance with the Ralph M. Brown Act and was available for public viewing and review at least 72 hours prior to schedule meeting date.

FISCAL IMPACT:

Limited to the allocated grant funding, which would provide for reimbursement of incurred project costs. Available grants total \$335,000. Bid price is \$202,369; \$23,500 is allocated for electrical work, and \$20,237 is contingency at 10%. CDBG funded projects use Fund 216. Cost accounting code: 700-23-51-9901; PM Code: 200302-47.00
