## A. Support for artists during Covid-19 – Artist Lottery

Committee Member Stucker made a motion that the drawing be postponed to their regular meeting on December 02, 2020 to allow for more entries.

The motion was not seconded.

The motion failed.

Committee Member Arnold made a motion to award \$500 to each of the three applicant's that have applied to date. A second lottery will be publicized and held in December. The rest of the money (\$2,500) will be awarded in \$500 grants to any additional applicants. If there are more than 5 additional applicant's a lottery will be held. If there are less than 5 additional applicants', the remaining funds will stay with the City.

Vice Chair Mills-Thysen asked Committee Member Arnold if he would be willing to amend his motion to state that the remaining funds will be dividend evenly amongst all applicants.

Committee Member Arnold was not in support of that amendment.

Vice Chair Mills-Thysen clarified that she was suggesting that each applicant receive an equal amount of funds regardless of when they were awarded (at this meeting or in December).

Committee Member Arnold expressed support for that, however, he would prefer to leave the awards at \$500 and, if there are not 5 additional applicants, a third lottery could be held early next year.

Committee Member Langberg seconded the amended motion.

The motion failed.

Vice Chair Mills-Thysen made a motion to award \$500 to each of the three applicant's that have applied to date. A second lottery will be publicized and held in December. The rest of the money (\$2,500) will be awarded in \$500 grants to any additional applicants. If there are more than 5 additional applicant's a lottery will be held. If there are less than 5 additional applicants', the full amount (\$4,000) will be divided evenly amongst all the applicant's (those awarded funds today and in December).

Committee Member Stucker seconded the motion.

Per a suggestion made by Committee Member Arnold, Committee Member Stucker volunteered to personally contact the organizations listed under 'Eligibility' on the call to see if they would be interested in participating, along with others that may come up.

Vice Chair Mills-Thysen requested that the Committee plan on voting on and approving the Call and press release at their regular December meeting so this can continue moving forward, assuming the City hears back from the County before then.

Vice Chair Mills-Thysen agreed to coordinate with staff on a press release before their regular December meeting.

C. Sculpture Garden Subcommittee RFP/Call for Artists

The Committee discussed and agreed upon further revisions to the RFP/Call for Artists.

Committee Member Stucker volunteered to contact a variety of artists and/or art groups and provide an update at the next meeting.

B. Ned Kahn Public Art – Update

The Committee received an update on Caltrans' response to Mr. Kahn's proposal for the Highway 12 bridge and discussed alternative sites.

Vice Chair Mills-Thysen made a motion recommending that staff investigate use of the knoll on Morris Street (across from the Community Center) and to present that as a site for Mr. Kahn's consideration.

Committee Member Langberg seconded the motion.
